The application along with the annexure is duly supported with affidavit by a competent person.

In licence issued to Jamshedpur Utilities & Services Company Ltd vide licence number 03 of 2006-07, issued for the area of supply for one district Saraikela- Kharsawan of Jharkhand State, Wherever the name of the petitioner Company appears as Jamshedpur Utilities & Services Company Limited (JUSCO) shall be substituted as Tata Steel Utilities and Infrastructure Services Limited (TSUISL).
