### Office Report

In compliance of order dated 05.02.2024 of the Hon'ble APTEL passed in Appeal no. 845 of 2023, several data is required to be submitted by the petitioner- Damodar Valley Corporation (DVC) as indicated below with regards to the petition for Category-wise Retail Supply Tariff from FY 2006-07 to FY 2011-12:

#### Data required to be submitted by the petitioner-DVC

1. DVC is directed to submit the break-up of its Non-tariff income, as reflected in the audited accounts for FY 2006-07 to FY 2011-12, duly segregated between its generation, transmission, distribution and other businesses. DVC should also submit the detailed breakup of the items booked under Miscellaneous heads.
2. DVC is also required to submit the basis for classification of the respective Non-Tariff Income element under the Generation/ Transmission/ Distribution/ Other Business head along with relevant documentary evidence in support of such classification. **The excel sheets depicting the computation and allocation of Income head among different Businesses is also to be provided.**
3. Further, each Income head under Non-Tariff Income claimed to the Distribution Business must be duly mapped to the appropriate Regulation of this Commission.

Based on the above, the required details are **to be provided for each financial year of the period FY 2006-12 as per the format (Linked excel copy also to be provided)** provided as under:
