Applications are invited for appointment to the post of Chairperson-cum-Member (Legal) for the Consumer Grievance Redressal Forum of Jharkhand Urja Vikas Nigam Ltd.(JUVNL) at Medninagar and Consumer Grievance Redressal Forum of Jamshedpur Utilities & Services Company Ltd. (JUSCO) at Gamharia in the District of Saraikela kharsawan.

1. As per the provisions of Electricity Act 2003 and JSERC (Guidelines for Establishment of Forum for Redressal of Grievances of the Consumers and Electricity Ombudsman) Regulations, 2011, the Jharkhand State Electricity Regulatory Commission requires the services of retired District/Additional District Judge for appointment to the post of Chairperson-cum-Member (Legal) for the Consumer Grievance Redressal Forum of Jharkhand Urja Vikas Nigam Ltd.(JUVNL) at Medninagar and Consumer Grievance Redressal Forum of Jamshedpur Utilities & Services Company Ltd. (JUSCO) at Gamharia in the District of Saraikela kharsawan. The applicant should possess the following qualifications and experience:
  - a) The candidate shall be possessing degree in Law and having at least 20 years of experience in Legal/Judicial work not below the rank of District/Additional District Judge.

- b) The candidate shall be persons of ability, integrity and standing who have adequate knowledge of and have shown capacity in dealing with the problems relating to Law.
  - c) The age of the candidate to be considered for appointment as Chairperson-cum-Member (Legal) shall be minimum 45 years and maximum 62 years as on 31<sup>st</sup> May 2016.
  - d) Every Member of the Forum shall hold office for a term of 5 years or 65 years of age, whichever is earlier. The Member shall not be eligible for reappointment to the same post.
  - e) The Chairperson-cum-Member (Legal) will get salary equivalent to the last pay drawn by them minus pension. The D.A and other allowances/ facility would be as per State Governments orders issued from time to time.
2. The candidates will have to furnish the following information through their employer organization where they are/were serving along with NOC together with the following documents/information latest by 30<sup>th</sup> June 2016.
- a) Up-to-date and complete ACR (atleast for last 10 years);
  - b) Vigilance clearance certificate.
  - c)(i) Whether any penalty has been imposed on the application in the past;
    - (ii) If so, give details;
    - (iii) Indicate if any penalty is in operation against the applicant as on date.

3. The candidates can apply directly to the undersigned on or before 30<sup>th</sup> June 2016 along with full bio-data and copy of degree on the basis of which he is applying.
4. The second copy of the application should be sent to the undersigned through the employer/last employer on or before 30<sup>th</sup> June 2016 with the above mentioned papers.
5. The crucial date for determination of eligibility of applicants for the post of Chairperson-cum-Member (Legal) will be 31<sup>st</sup> May 2016.
6. The application should be sent to the undersigned indicating the choice for place postings in order of preference.
