		A petition has been filed on behalf of the licensee-JSEB	
		stating, inter-alia, that for constitution of four CGRFs at Dumka,	
		Chaibasa, Hazaribagh and Medininagar approval of the Board	
		is required for which detailed agenda has been prepared on	
		which permission has been accorded by the Chairman, JSEB	
		for placing it before the Board for approval. It has further been	
		stated that after approval of the agenda by the Board, a panel	
		of persons to be appointed as Members of the Forum will be	
		forwarded for approval of the Commission and thereafter the	
		Members of the Forum will be appointed. In order to complete	
		all these formalities three months time has been prayed for.	
		Perused the petition.	
		The issue relating to formation of CGRF in the	
		remaining four Revenue Divisions are pending with the	
		licensee-JSEB since last more than one year. In the Tariff	
		Order of JSEB for FY 2010-11 issued on 26.4.2010 also, the	
		Commission had directed the licensee-JSEB to set up new	
		units of CGRF within six months of the issue of Tariff Order. In	
		compliance of the said direction, the licensee-JSEB vide its	

letter No. 1383 dated 30.11.2010 had informed the Commission that the licensee-Board is in process of establishing four more CGRFs. Though more than seven months have elapsed from this date; no progress was reported. Now, when the Commission has initiated the instant suo-motu proceeding, the licensee-JSEB has come up with a petition for grant of three months time for taking approval of the Board.

In view of the above, the Commission feels that the licensee-JSEB is not serious in complying with the directions of the Hon'ble Appellate Tribunal for Electricity as well as of the Commission relating to formation of CGRFs in the remaining four Revenue Divisions of Jharkhand. However, taking a lenient view, the Commission directs the licensee-JSEB to complete all the formalities for establishing the CGRFs in the remaining four Revenue Divisions Headquarters separately viz. Medninagar, Dumka, Hazaribagh and Chaibasa within three months and send a panel of persons one each from Engineering and Finance & Accounts streams for appointment as Members of these four Forums. The Commission would nominate one Independent Member each for these four CGRFs from Legal stream.

Post the matter on **27.08.2011** at **11.30 AM** for monitoring further progress on the proposed four CGRFs.
