Date of Proceedings of the Commission with signature Office proceeding action taken with date 2 3 4 03.11.2011 The Tariff Order for FY 2011-12 of Tenughat Vidyut Nigam Limited (hereinafter referred to as "TVNL") was issued by the Commission on 31.05.2011. In the said tariff order the Commission had issued various directions for compliance within a specified period of time for each item. In compliance, the Generator-TVNL has submitted only one quarterly report regarding performance report & Outages of Station during first quarter of FY 2011-12. Regarding secondary fuel oil (LDO) consumption and breakdown of TTPS-Biharshariff Transmission lineconsequential forced shutdown of one unit of TTPS, generator-TVNL vide letter No. 411/11-12 and No. 409/11-12 dated 14.07.2011 requested the Commission

1. to reconsider the points mentioned therein. On receipt of the letters the generator-TVNL was asked vide letter No. JSERC/03/TVNL/285 dated 20.07.2011 to file a proper petition for redressal of the grievances. But the generator-TVNL did not file the petition. Regarding Power Purchase Agreement (PPA) between TVNL and JSEB and recovery of dues, the Commission had directed to the generator-

TVNL to renegotiate its PPA and get the same ratified by the Commission. But this has also not been done. The generator-TVNL has simply forwarded a copy of their letter No. 423/11-12 dated 18.07.2011 and No. 642/11-12 dated 29.9.2011 addressed to the Chairman, JSEB, Ranchi. No outcome has been reported to the Commission as yet. Further, as regards the other directives, no compliance has been sent till date.

As provided in the JSERC (Terms & Conditions for determination of Generation Tariff) Regulations, 2010, the tariff for the Generating companies has to be determined under the MYT framework during the Control Period which will commence from April 2012 to March 2016. Clause 6.6 of the said Regulations provides for filing the Business Plan for the Control Period for the generating plants by June, 2011, but the generator-TVNL neither filed the compliance of the directives, in full, nor the Business plan to the Commission. As such, the Commission, taking a lenient view, directed the generator-TVNL to file the Business Plan for its generating plants by 1<sup>st</sup> November, 2011 along with the petition for determination of tariff under the MYT framework. The said direction of the Commission was communicated vide letter No. JSERC/17/Vol. II/ 418 dated 15<sup>th</sup> September, 2011.

In response to the aforesaid letter dated 15<sup>th</sup> September of the Commission, the Electrical Executive
