1.	03.11.2011	<p>The Tariff Order for FY 2011-12 of Jharkhand State Electricity Board (hereinafter referred to as "JSEB") was issued by the Commission on 22.07.2011. In the said tariff order various directions were given relating to submission of report regarding performance of power plants at Patratu and Sikidri for compliance within a specified period of time. But the JSEB has not submitted compliance for any of the directions relating to its Power Plants.</p> <p>Further, as provided in the JSERC (Terms & Conditions for determination of Generation Tariff) Regulations, 2010, the tariff for the Generation functions has to be determined under the MYT framework during the Control Period which will commence from April 2012 to March 2016. Clause 6.6 of the said Regulations provides for filing the Business Plan for the Control Period for the generating plants by June, 2011, but the JSEB neither filed the compliance of the directives nor filed the Business plan to the Commission. As such, the Commission, taking a lenient view, directed the JSEB to file the Business Plan for its generating plants by 1st November, 2011 along with the petition for determination of tariff under the MYT framework. The said direction of the Commission was communicated vide letter No. JSERC/17/Vol.II/418 dated 15th September, 2011.</p>	

In reply to the aforesaid letter, the Chief Engineer (C&R) of JSEB vide letter No. 1552 dated 31.10.2011 read with letter No. 1554 dated 31.10.2011 has requested to grant time till 31.12.2011 for filing the Business Plan for Generation function and ARR/Tariff petition for FY 2012-13 on the ground that as of now the JSEB is vertically integrated entity and as per direction of the Commission the ARR/Tariff petition for Generation, Transmission and Distribution have to be submitted separately for which all out efforts are being taken. It has further been stated the JSEB is also taking all out efforts to submit the compliance of directives given in the Tariff Order for FY 2011-12 which has also been taken up. In view of the above, it has been prayed to grant an extension of two months time i.e. upto 31.12.2011 for filing Business plan of generation function & ARR/Tariff petition for the FY 2012-13.

Perused the letter. Register it.

Considering the facts and circumstances mentioned in the letters dated 31.10.2011 of the JSEB the prayer is allowed. The JSEB is directed to adhere to the time-line given by it and must ensure to file the MYT Business Plan and MYT tariff petition by 31st December, 2011 along with the audited Accounts and consolidated compliance report of the directions issued in the Tariff Order for FY 2011-12.
