		Steel Limited (hereinafter referred to as "licensee-TSL")	
		was issued by the Commission on 27.08.2011. In the said	
		tariff order various directions were given relating to	
		submission of report on the performance of distribution	
		business of the licensee-TSL within a specified period of	
		time. But the licensee-TSL has submitted compliance	
		report on replacement of defective meter and information	
		on achievement of Standard of Performance. The report	
		on other directions mentioned in the Tariff Order for FY	
		2011-12 has not been submitted.	
		Further, as provided in the JSERC (Terms &	
		conditions for determination of Distribution Tariff)	
		Regulations, 2010, the tariff for the distribution business of	
		the licensees has to be determined under the Annual	
		Tariff framework for the transition period FY 2012-13 for	
		which the tariff petition was to be filed by 1st November	
		2011. In this context the General Manager (Power	
		Services) of the licensee-TSL vide his letter No.	
		PBD/336/59/11 dated 28.10.2011 has submitted that they	
		are preparing the application along with the applicable	
		formats in line with the Regulations specified by the	
		Commission, but all their Accountants are busy in half	
		yearly audit of Accounts and the same is taking more time	
		than was actually anticipated by them. It has further been	
		stated that audit of Accounts of Power Business may also	
		take some more time by their Auditor. It has also been	
		mentioned that to comply with the directives of the	

Commission to submit assest-wise details of GFA for computation of depreciation for FY 2011-11 and FY 2011-12 will also take some more time to complete. In view of this it has been requested to allow the licensee-TSL to file the petition by 1<sup>st</sup> week of December,2011.

Perused the letter. Register it.

Considering the seriousness of the licensee-TSL in filing the tariff petition for FY 2012-13 along with audited Accounts and the compliance of the directions, the prayer of the licensee-TSL is allowed.

Post this case on 10.12.2011 at 11.30 AM for further orders. In the meantime the licensee-TSL must file the tariff petition for FY 2012-13 along with the audited Accounts and consolidated compliance report on the directions issued in Tariff Order for FY 2011-12.
