		Jharkhand State Electricity Board (hereinafter referred to	
		as "licensee-JSEB") was issued by the Commission on	
		22.07.2011. In the said tariff order various directions were	
		given relating to submission of report regarding	
		performance of distribution business of the licensee-JSEB	
		within a specified period of time. In compliance the	
		licensee-JSEB has submitted compliance report only on	
		one of the directions relating to complaint redressal	
		mechanism. The compliance report on other directions	
		mentioned in the Tariff Order for FY 2011-12 have not yet	
		been submitted by the licensee-JSEB.	
		Further, as provided in the JSERC (Terms &	
		Conditions for determination of Distribution Tariff)	
		Regulations, 2010, the tariff for the distribution business of	
		the licensees has to be determined under the Annual	
		Tariff framework for the transition period FY 2012-13 for	
		which the tariff petition was to be filed by 1st November	
		2011.The licensee-JSEB was also intimated the directions	
		of the Commission in this regard vide letter No. 418 dated	
		15 th September 2011 to file separate petition for	

determination of the Distribution tariff as per the Annual Tariff framework. In response to the said letter the Chief Engineer (C&R) of the licensee-JSEB vide his letter No.1554 dated 31.10.2011 has informed that as per the direction of the Commission the ARR and Tariff petition for Generation, Transmission & Distribution have to be submitted separately for which all efforts are being taken by them. Further, it has also been intimated that efforts to submit the compliance of directives given in the Tariff Order for FY 2011-12 has also been taken up by them. But for filing the ARR and tariff petition of distribution business of the licensee-JSEB it has been prayed to grant two months i.e upto 31.12.2011.

Perused the letter. Register it.

Considering the seriousness of the licensee-JSEB in filing the tariff petition for FY 2012-13 along with the compliance of the directions, the prayer of the licensee-JSEB is allowed.

Post this case on **02.01.2012** at **11.30 AM** for further orders. In the meantime the licensee-JSEB must file the tariff petition for FY 2012-13 along with the consolidated compliance report on the directions issued in Tariff Order for FY 2011-12 and the audited Accounts.

Let a copy of this order be sent to the licensee-JSEB.
