03	26.10.2016	Affidavits have been filed by the JBVNL, DVC, SAIL-Bokaro, JUSCO, Inland Power Limited, APNRL, Tata Power and TVNL in purported compliance of the order dated 14.09.2016. All the affidavits are incomplete. They individually prayed for four weeks time for filing complete affidavit in compliance of the said order.	

In course of hearing, the victims who were present in large number have explained their wose. In some cases inspite of long lapse of time since the death occurred of the bread earners dependent(s) have not been paid any compensation. In some cases paltry amount has been paid in the name of compensation to the dependents of the deceased and the victim of loss of limbs like hands/legs-causing permanent disability. According to the victims, even the medical expenses have not been paid by the JBVNL and they had somehow manage money to pay medical bill, in some cases, by disposing of their lands and other valuables.

The DGM (Personnel), JBVNL, Govind Yadav who is present, was asked to note down the complaints and respond to them. He noted down the complaints but expressed his inability to reply at the moment without going through the relevant papers.

Leaned Council on behalf of the JBVNL submitted that categorical affidavit regarding redressal of the complaints individually shall be filed along with the affidavit to be filed in compliance of
