		07.03.2018 in Ranchi on ARR & Tariff Petition of JBVNL,		
		it was pointed out before the Commission that the claims		
		of the JBVNL with regards to uploading of the documents		
		and figures on the website be verified. Upon verification of		
		the claim, it was discovered that JBVNL had not uploaded		
		any of the audited accounts, and thereby committed		
		gross irregularity to the public at large as well as the		
		Hon'ble Commission.		
		He further submitted that in compliance with the		
		direction given by the Hon'ble Commission, JBVNL		
		uploaded the documents. Now when JBVNL has		
		uploaded the audited accounts on its website, the		
		Commission should give the petitioner one month time for		
		filing objections based on the audited accounts and a		

fresh public hearing be conducted.

The learned counsel for the petitioner filed the rejoinder and submitted that the claim of the petitioner that during the public hearing on the 7th March 2018, the audited accounts of JBVNL were not found on the website is completely wrong.

Only the CAG Audit Report for FY 2015-16 was not visible on the website due to inadvertent technical error, though audited accounts for that year, and audited accounts and audit report for all other relevant years were available on the website.

The learned counsel for JBVNL further submitted that during the public hearing itself, the Commission directed JBVNL to immediately upload the CAG report in a manner which makes it easily accessible, and allowed one week time from the date, the relevant CAG report is uploaded to file any further objections to the petition.

The learned counsel for the respondents submitted that as per the direction during the public hearing, the JBVNL uploaded the relevant CAG Audit Report on the same date; the objectors during the public hearing including the petitioner in this case were also informed the same day vide its letter number 322/Ranchi dated 07.03.2018.

The learned counsel further submitted that a public notice in newspaper has also been issued on 17th March, 2018, inviting further comments within a week.

A copy of the letter and public notice were made

available to the learned counsel for the petitioner.
