02	14.09.2016	When the matter is taken up for hearing learned counsel for JBVNL, JUSNL, JUUNL & JUVNL submitted that they have prepared chart of the deceased persons and the persons who are victims of the accidents and also the persons who have lost their lives or property due to fault in the system and shall file specific affidavit regarding the scheme which has been framed by the companies to deal with such incidents, details of compensation paid to the deceased family/ injured persons and the persons who have otherwise lost their lives and properties. Besides, they shall also file detailed affidavit regarding the safety measures, which have already been taken with the facts and figures of the safety equipments supplied to the persons engaged in the work	

viz. line men etc. and further improved safety measure plan to minimise the rate of such accidents/loss of life and property.

For that purpose learned counsel prays for six weeks time.

Learned counsels and representatives of DVC, SAIL and the representatives of JUSCO, TSL and APNRL have also made the same submissions and prayer.

Six weeks time, as prayed for, is allowed to the respondents to file affidavit giving detail of the scheme, the number of fatal accidents, injuries and damages to the human life causing disablement (permanent/temporary), compensation paid, other measures for rehabilitation to the family of the deceased and the injured persons or sufferers, nature of employment, safety measures prescribed, equipments supplied to avoid such incidents/accidents/injuries, further plan/scheme for avoiding such loss of life/ property/incidents/ accidents, measures taken for awareness of the safety measures of the concerned persons/personnel engaged in such work by the utility in the works of maintenance/ installation etc., details of the persons who have been given safety training.

The respondents shall submit the said particulars/ descriptions regarding the persons identified by them as also the names which may be received by and sent to the Commission as also those received by them from the
