Sub: Objection to DVC Tariff Petition

Sir,

This is in reference to the Objections / Suggestions submitted by M/s Shree Dwarikesh Ecotex Pvt. Ltd. vide their letter reference no. SDEPL/Gen./2020-21/006, dated 18th August 2020.

At the outset DVC would like to indicate that proposed hike in tariff is not in the range of 25% or 40% as alleged by the objector. Compared to the Average Cost of Supply (ACoS) last approved by the Hon'ble Commission for FY 2019-20 in the tariff order dtd. 28.05.2019, DVC has proposed much lesser hike for FY 2020-21. Reply on the other issues as mentioned by the objector are furnished as under;

- A. <u>Adjustment of revenue surplus of past period</u>: As directed by Hon'ble Commission DVC has already submitted its road map towards settlement of past dues along with all relevant details. All such submissions are still in public domain. DVC will abide by the directive of this Hon'ble Commission as may further be given to DVC in this regard.
- B. <u>Difficulty during the lockdown period due to COVID-19:</u> DVC acknowledges the difficulties faced by different industries during the lockdown period. Economic activities in the whole country slowed down in general due to the pandemic situation. Demand of electricity also nosedived to a minimum level. As a result DVC has also been facing a tough time. Despite of such a tough time faced by DVC, it continued with 24 x 7 power supply to all the consumers despite of delay in making payment of the electricity bills. Such arrangement continued until 1st August 2020. In doing so DVC had to bear the cost of additional working capital.
- C. Reduction of Tariff: The proposal made by the objector before this Hon'ble Commission for reduction of tariff by 15% is without any justification and without any back-up computational details. Accordingly it is humbly submitted before this Hon'ble Commission that the suggestion of the objector for reduction of tariff has no merit for its acceptance.

D. DVC also humbly submits before this Hon'ble Commission that during the lockdown period due to sudden and drastic reduction of demand of the consumers fixed cost recovery became abysmally low. Cash flow also suffered badly. DVC therefore resorted to short term cash credit to make good the bare minimum requirement to maintain day-to-day requirements and activities which are must do in nature for 24 x 7 power supply. Hon'ble Commission is therefore requested to appreciate the ground reality and allow DVC to recover the additional cost of supply in a justified manner.
