		- Damodar Valley Corporation (DVC) for determination of	
		Fuel Price & Power Purchase Adjustment (FPPPA) for the	
		part of their DVC area falling within the territory of the	
		State of Jharkhand for the period 1.4.2014 to 31.12.2014	
		under the provision of Sections 62, 64 and 86 of the	
		Electricity Act 2003 read with the provisions of Damodar	
		Valley Corporation Act, 1948 as also JSERC (Terms &	
		Conditions for determination of the distribution tariff)	
		Regulations 2010.	
		The interveners claiming themselves as an	
		Association of DVC HT consumers of Jharkhand filed	
		objection to the petition mainly on the ground that the	
		petition is not complete. The prayer is for determination	
		of FPPPA for the period from April 2014 to December	
		2014 although the same ought to have been for the period	
		ending March 2015. Secondly, that the petition is not in	
		accordance with the provisions of Regulations.	
		The said objections have been replied to by the	
		petitioner-DVC stating that the petition has been made	

considering the cost/quantum of actual power purchase for the period from 1.4.2014 to 31.12.2014. The petitioner-DVC was aggrieved by certain aspect of JSERC MYT order dated 4.9.2014and has filed appeal before the Hon'ble Appellate Tribunal for Electricity being Appeal No. 55 of 2014.

Learned counsel for the intervener submitted that the subject matter of the said matter does not cover the period and as such has no relevance.

Having heard the learned counsels for the parties and considering the submissions made by the learned counsels at the time of hearing as also the norms in the JSERC (Terms & Conditions for Distribution Tariff) Regulations and the recent prevailing policy decision to that regard, this petition is disposed of directing the petitioner to make computation of FPPPA charges of the said period strictly in accordance with the provisions of the Regulations as were then applicable and charge the same from the consumers on the basis of actual variation in fuel cost. The impact and revenue collected through FPPPA shall be accounted for separately and submitted to the Commission at the time of filing of petition for ARR and Tariff determination. The adjustments shall be pass through in the True up.

The petition is disposed of.
