1. The suo-motu proceeding was initiated on 17.07.2023 to fix the schedule of fees for filing applications and petitions by State Load Despatch Centre (SLDC), Ranchi.
2. The petitioner State Load Despatch Centre (SLDC), Ranchi vide its letter no.73 dated 27.03.2023 has also sought clarification regarding the applicable fees for filing petition by State Load Despatch Centre (SLDC), Ranchi.
3. It is observed that the Clause 7 of SCHEDULE-I: FEES, FINES AND CHARGES' of Jharkhand State Electricity Regulatory Commission (Conduct of Business) Regulation 2016 do not provide the fee for filing applications and petitions by State Load Despatch Centre (SLDC), Ranchi.
4. Further, it is observed that Clause 1 (i) of 'SCHEDULE-I: FEES, FINES AND CHARGES' of the JSERC (Conduct of Business) Regulations, 2016 states as quoted below,

“i. Every application, petition and appeal made to the Commission shall be accompanied by such Fees as specified in the Schedule.

ii. The Fees payable under these Regulations shall be paid by means of bank draft or pay order, drawn in favour of Jharkhand State Electricity Regulatory Commission, payable at Ranchi.

iii. The fee received shall be entered in the register prescribed for the purpose in the form as in Annexure 10”.

ORDER

5. Considering the facts and circumstances of the case as well as non-availability of specific clause regarding schedule of fee for filing applications and petitions by State Load Despatch Centre (SLDC), Ranchi, therefore after deliberation and discussion, the Commission has decided to incorporate a

new clause 7.A as fee schedule for SLDC, the clause 7.A is reproduced hereunder:

7.ASLDC Fees Schedule

S.No.	Description	Fees & Charges
1.	Petition for approval of investment/ Business plan of the SLDC	Rs 2,00,000.00
2.	MYT Framework	Rs 2,00,000.00
3.	Application for truing up, APR, ARR filed as a combined petition	Rs 3,00,000.00
4.	Application for truing-up/APR/ARR if filed as a separate petition	Rs 1,50,000.00
5.	Application for review of Order	Rs 1,00,000.00

6. The above clause 7.A shall form part of the Principal Regulation JSERC (Conduct of Business) Regulations, 2016.
7. The suo-moto case is disposed of with the above observation.
