**Sub :- Waiver of Demand \ Fixed charges of Industrial Consumer for the period
01\03\2020 to 30\06\2020 regarding HT Consumer No. SNL – 0066.**

Dear Sir,

In the light of Registered suo moto case No. 15 of 2020 with regard to the above subject and Public Comments invited on the burning issues of suo moto case, we would like to submit as under :-

1. That we are operating a sponge iron unit having the capacity of 4X100 TPD DRI KILNS , located at Village- Senegarha, P.O. Rabodh, Distt :- Hazaribagh, Jharkhand.
2. That we are getting Power Supply from Giddi P\S\S through Religarha Feeder on 11 KV line having with 1300 KVA Contract Demand.
3. That due to COVID – 19 Pandemic many industrial consumers have suffered in several ways. Their production has been hampered during the month of March 2020 to June 2020. Similarly, our Production was totally stopped w.e.f. 24\03\2020 to 15\05\2020 and consequences of that the Company suffered heavy financial loss.
4. That the Govt. has granted several facilities and financial relief to the industries and other sector by way of extending the date of deposit of GST & also reducing the slab from 18% to 9% on several commodities.
5. That the due date of interest payment on Bank loan has also been deferred for 6 months . No interest will be charged for the deferred period as the period has been extended for 6 months & more.
6. That easy & soft loan without collateral has also been granted to the industry from Banking Sectors for their survival.

7. That in addition to the above, so many relief have been granted by the Central Govt. as well as State Govt. to the different sectors of industries to meet the panic situation and financial crisis arisen by the grievous and painful effect of COVID -19 PANDEMIC.

It has been a welcome move by the Jharkhand State Electricity Regulatory Commission to have registered a suo moto case for granting relief to the consumers by having brought the proposal for waiver of Demand\ Fixed Charges for the esteemed consumers.

We shall ever remain highly grateful to you for this act of kindness.
