The Present comments/representation is based on the "Public Notice" appeared in the daily Newspaper for waiver of fixed demand charge.

We are very much grateful to the Hon'ble commission for taking up the matter and register a Suo –moto case no.15/2020.

At the same time we expressed our gratitude towards the present state govt. for realizing the financial set back condition due to the Lockdown.

The government is very much concerned about the industrial consumers as such a clear direction U/S 108 of the Electricity Act 2003, to the Hon'ble commission for relief of waiver of Fixed demand charges.

We are running an industry in the territorial jurisdiction of Adityapur industrial area where JBVNL is licensee.

As your kind self is aware of the fact that the State as well as Central govt. has imposed "Lockdown" since 22/03/2020 to control spread of COVID-19 pandemic as such our business has been completely closed. During this lockdown we could not operate our business and all transaction have remained stopped / suspended.

We are operating an Ice-cream factory so it can be realized that to maintain the quality of finished product we have to run cold rooms. We had to use a minimum load; otherwise electricity units are consumed for the purpose to maintain safety, security and maintenance work only.

Inspite of knowing the situation of lockdown the service provider JBVNL forcefully assessing and realizing the demand charge as per the tariff provisions.

We want to clarify, when our business establishment is totally under Lockdown how the Fixed charge can be levied. We appreciate the concern of the state government, who directed the Hon'ble commission for waiver of Fixed demand charge.

If the fixed demand charge is realized without consumption it will be unjust recovery. The state government is considered about the levy of Fixed demand charge which is illogical. Imposition of Lockdown is viewed as forced majeure because the COVID-19 pandemic is unforeseeable circumstance. Any such situation is considered as public interest. The present situation is beyond human control.

Under the situation expressed above we want to provide a chart showing the KVA consumption by us for the period from February 2020 to June 2020. From perusal of the chart this can be ascertained that whatever we have stated is true.
