The application in the format is to be submitted to the Secretary, Jharkhand State Electricity Regulatory Commission, 1st Floor, Jharkhand State Housing Board (old headquarter), Harmu Housing Colony, Ranchi-834002 along with self attested copies of certificates/Mark sheets for education qualifications (starting from matriculation), category, self attested passport size recent photograph and details of experience, if any, through **registered/speed post only so as to reach latest by 12/10/2023** upto 5:00 P.M.
- 6. Reservation will be applicable as per Govt. of Jharkhand norms
- 7. The age limit will be as per the State Government rules.
  - \* Temporarily engaged/working staff of the Jharkhand State Electricity Regulatory Commission will get age relaxation upto the number of years already worked in the Jharkhand State Electricity Regulatory Commission.
- 8. The candidates will have to appear for written test/interview as decided by the Commission.
- 9. The Commission reserves the right to shortlist the applications and only shortlisted candidates will be called for written test / interview.
- 10.Preference and weightage shall be given to the candidates who have worked in Jharkhand State Electricity Regulatory Commission in the following manner:
  - For every 10 years of continuous service of any candidates in Jharkhand State Electricity Regulatory Commission, extra 10 marks will be given to the said candidate.
  - For every 15 years of continuous service of any candidates in Jharkhand State Electricity Regulatory Commission, extra 15 marks will be given to the said candidate.
  - For every 20 years of continuous service of any candidate in Jharkhand State Electricity Regulatory Commission, extra 20 marks will be given to the said candidate.
- 11. Candidates in Central/State/UT government service or in the service of Autonomous/Statutory Body/PSUs/Corporations etc. should apply through proper channel only. The applications of such applicants should be forwarded along with a "No Objection Certificate" from their parent Department and duly enclosing attested copies of Annual Confidential Reports of last five years and vigilance clearance certificate.
