NOTICE

Applications are invited for appointment to the post of Electricity Ombudsman

1. As per the provision of Electricity Act 2003 and Guidelines for establishment of forum for redressal of Grievances of the Consumers Electricity Ombudsman and Consumer Advocacy Regulations 2020 and its first amendment 2022, the Commission needs to appoint an Electricity Ombudsman. The applicant for Electricity Ombudsman should possess the following qualifications and experience:
 - a) The Candidate shall be a person of experience, ability, integrity and standing to be selected by the Commission from amongst, a working/retired Principal District Judge or District Judge who held a judicial office, for not less than 25 years or a person who held a post of Secretary in the State Government for not less than 25 years or a working/retired Chief Engineer or equivalent of an Electricity sector utility having experience of not less than 25 years.
 - b) Desirable to have experience of working in Consumers' Grievance Redressal system.
 - c) The minimum age of the candidate to be considered for appointment as Electricity Ombudsman shall be 45 years as on **01.08.2022**
2. The Ombudsman of the Commission shall be appointed on Full time basis to discharge exclusively the function of the Electricity Ombudsman and he shall not hold any other post or undertake any other work.
3. Ombudsman shall hold office for a term of five years or Sixty-Five years of age, whichever is earlier. Initial appointment shall be for a period of three years extendable up to further two years on satisfactory service. No person shall be appointed after attaining age of 62 years as on **1st August 2022**.
4. The remuneration payable to Electricity Ombudsman shall be equivalent to last pay drawn by him/her minus pension and will be borne by the Commission. The dearness allowance, conveyance allowance, house rent allowance and telephone facilities shall be as per Orders issued by Commission from time to time. In the case of Ombudsman not getting pension, the monthly honorarium payable to such Ombudsman shall be equal to the last pay drawn.
5. The candidates will have to furnish the following information through their employer organization which they are/were serving along with NOC together with the following documents/information latest by **10.10.2022**
 - a) Up-to-date and complete ACR (atleast for last 10 years)
 - b) Vigilance clearance certificate.
 - c) i) Whether any penalty has been imposed on the applicant in the past;
 - ii) If so, give details.
 - iii) Indicate if any penalty is in operation against the applicant as on date.
6. The candidates can apply directly to the undersigned through registered/speed post on or before **10.10.2022** along with full bio-data and copy of degree on the basis of which he is applying.

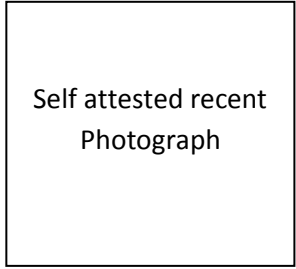
7. The second copy of the application of a working/serving officer should be sent to the undersigned through the employer/last employer on or before **10.10.2022** with the above mentioned documents.
8. The crucial date for determination of eligibility of applicants for the post of Ombudsman will be **01.08.2022**
9. The application received after last date will not be considered.
10. Incomplete application or submitted in different format are liable to be summarily rejected. The Commission reserves the right to not consider the applications if found incomplete in any respect.
11. The decision of the Commission shall be final and binding on all concerned and no communication shall be entertained.
12. The Commission also reserves the right not to fill above post without assigning any reason. In the case of such eventuality, the notice of such vacancy shall be treated as Cancelled.
