Applications are invited for appointment to the posts of Third Member (Independent) for the Consumer Grievance Redressal Forum of Jharkhand Bijli Vitran Nigam Limited at Ranchi, Hazaribagh, Chaibasa, Medininagar and Dumka.

1. As per the provision of the Electricity Act 2003 and Jharkhand State Electricity Regulatory Commission (Guidelines for establishment of forum for redressal of Grievances of the Consumers Electricity Ombudsman and Consumer Advocacy) Regulations 2020 and its amendments thereof, the Commission needs to select **Third Member (Independent Member) for the Consumer Grievance Redressal Forum of Jharkhand Bijli Vitran Nigam Limited at Ranchi, Hazaribagh, Chaibasa, Medininagar and Dumka.** The applicant for the Third Member (Independent) should possess the following qualifications and experience:
 - a) The person shall be representative of a registered society/NGO/consumer organization having one of its main objectives as consumer protection with at least 5 years of standing or alternatively the representing member should have five years of experience in consumer-related matters.
 - b) The minimum age of the candidate to be considered for appointment as Third Member (Independent) shall be 45 years as on **01.08.2022**
2. The Third Member (Independent Member) of the Consumer Grievance Redressal Forum (CGRF) shall not have been in the employment in any capacity under, or agency of, the Distribution Licensee for a minimum period of three (3) years prior to being appointed Independent Member of the Forum.
3. Third Member (Independent Member) shall hold office for a term of five years or Sixty-Five years of age, whichever is earlier. Initial appointment shall be for a period of three years extendable up to further two years on satisfactory service. No person shall be appointed after attaining age of 62 years as on **1st August 2022**.
4. The candidates will have to furnish the following information through their employer/organization/registered society/NGO/consumer organisation (as applicable) which they are/were serving along with NOC together with the following documents/information latest by **06.01.2023**.
 - a) Up-to-date and complete ACR (atleast for last 05 years)
 - b) Vigilance clearance certificate.
 - c) i) Whether any penalty has been imposed on the applicant in the past;
 - ii) If so, give details.
 - iii) Indicate if any penalty is in operation against the applicant as on date.
5. The candidates can apply directly to the undersigned through registered/speed post on or before **06.01.2023** along with full bio-data and copy of degree on the basis of which he is applying.
6. The second copy of the application of a working/serving applicant should be sent to the undersigned through the employer/last employer on or before **06.01.2023** with the above mentioned documents.

7. The crucial date for determination of eligibility of applicants for the post of **Third Member (Independent Member)** will be **01.08.2022**
8. The application received after last date will not be considered.
9. Incomplete application or submitted in different format are liable to be summarily rejected. The Commission reserves the right to not consider the applications if found incomplete in any respect.
